## Training & Support

# Q. How many places for training contracts are available for September 2028?

A. Four

# Q. How do I apply for the summer vacation scheme and/or a training contract?

A. Application is via our online form, which you can access via our website

www.gordonsllp.com/careers/graduate-trainee-solicitor So that the recruitment process is fair, all candidates must apply via this form. CVs will not be accepted.

#### Q. What is the deadline for the application?

A. If you are applying for a training contract via the summer vacation scheme then you will need to submit your application by 31 December 2025. Applications received after this date and up to 30 April 2026 will be considered for a training contract only.

### Q. I applied to Gordons last year... can I apply again?

A. Yes, of course, but you will need to complete a new up-to-date application.

# Q. I don't have a law degree... does that matter?

A. Not at all.

# Q. I don't have any legal work experience. Will this count against me?

A. We appreciate that securing work experience can be as competitive as applying for a training contract, so don't worry if you haven't had the opportunity to do any legal placements yet. Whilst these are a great way of putting theory into practice, any non-legal work that you've undertaken can also provide transferrable skills.

#### Q. Do you run any insight events?

A. We will be holding an insight evening at our Leeds office on 13 November 2025 where you have the opportunity to hear from our partners and trainees about their Gordons journey, see our office and network with our staff in a relaxed environment. #### Q. When should I start applying for a training contract?

A. Recruitment for training contracts generally takes place two years in advance, which means that for law students, the earliest you can apply is during the penultimate year of your degree. Non-law graduates undertaking the GDL and SQE full time can apply before starting their legal studies.

Whether you've got a law or non-law degree, you must have completed the LPC or SQE1&2 before you start your training contract.

# Q. I've submitted my application but have additional work experience/exam results that I want to tell you about. Is it too late?

A. Our application form enables you to make amendments after submission up to the closing date.

# Q. Does it matter where I study the GDL/SQE or which electives I do?

A. If you are already underway with your postgraduate legal studies then we don't mind which institution you choose to undertake your course. If you are offered a training contract with us and are yet to start, then our law school of choice for postgraduate study is BPP Leeds.

With regards to electives, as you are guaranteed to have a six-month seat experiencing commercial property work, our trainees have suggested that an elective in a complementary topic can help. However, this is entirely your choice.

### Q. Does Gordons offer any sponsorship?

Yes, we offer our trainees sponsorship towards future SQE studies.

# Q. I'm thinking of taking a gap year. Will this count against me?

A. Not at all. It's what you do with the time that counts!

#### Q. Are there opportunities for paralegal work?

A. Such opportunities arise on an ad-hoc basis and will be advertised on the general vacancies section of our website. If you would like your details to be held on file for possible future paralegal vacancies and / or summer work, please forward your CV and availability to recruitment@gordonsllp.com.

# Q. Great! I've been offered a training contract at Gordons. What happens next?

A. It may take up to two years until your training contract commences, but rest assured, we won't forget about you. As a prospective trainee, you will receive updates about the firm and be invited to social events so that, by the time you start with us, you will already know your fellow trainees and have met many of our partners and staff, helping to settle you quickly into life here.

#### Q. Any final tips?

A. Make sure that you have completed all sections of the application fully, checking for spelling and grammatical errors. If you want to be a lawyer, attention to detail comes in pretty handy!
